If an NGB must inform an individual that they cannot participate, inform the individual that there is an issue with their eligibility and they must contact the U.S. Center for SafeSport at resolutions@safesport.org or 833-587-7233. You should not provide any other details of the allegations.

The list below is not an exhaustive list of individuals who have committed USA Climbing actual or alleged conduct violations, nor is it an exhaustive list of individuals who are not currently eligible to participate or who previously were not eligible to participate. By way of illustration and without limitation, the list below does not include persons who are serving or previously served a probationary period; may not include those who served a prior period of suspension, or who received a warning; does not include individuals whose cases were administratively closed by the U.S. Center for SafeSport such as for lack of jurisdiction or insufficient information; does not include persons who failed to attain a USA Climbing certification such as for failing to pass a background screen.
