Rulebook Addendum

This USA Climbing Rulebook Addendum (Rulebook Addendum), which replaces all prior Addenda, each in its entirety, is to be read in conjunction with USA Climbing Rulebook 2024-2025 version 20240927 (Rulebook).

Where there is any conflict between this Rulebook Addendum and the Rulebook for any rule, this Addendum shall govern.

To assist the reader in identifying the changes contained in this Rulebook Addendum, commentary text, if any, is presented in *italic text*, rule text that has been added is marked in <u>red underlined text</u>, and rule text that has been deleted is marked in <u>red strikethrough text</u>.

B1 Category Paraclimbing competitors may provide their own blindfold, subject to Jury President approval, as updated in 3.6.2:

3.6.2 A competitor must wear a top, bottoms, climbing shoes and (where relevant) a harness during their attempts. If competing in the B1 Paraclimbing category (i.e., equivalent to an IFSC category that requires a blindfold), a competitor must wear a blindfold either provided by the Event Organizers or approved by the Jury President.

Note if the relevant officials (e.g., Jury President) are unable to sufficiently inspect a harness (e.g., a harness that is integrated into clothing) a Head Judging Official may determine that they are unable to evaluate the harness's level of safety and therefore disallow the harness under the Safety rules in Rule 3.1 and Rule 7.3.3.

The Jury President may take steps outlined in 7.8.6 to ensure fair access to a route/boulder when a competitor appears to be making little progress on a route/boulder without a time limit:

7.8.6 The Jury President has the discretion to instruct a Classic Redpoint or Modified Redpoint competitor to make progress on an attempt or risk having their attempt terminated and must only do so in a fair and consistent manner. Before terminating the attempt, the Jury President should make a reasonable attempt to determine that the competitor's attempt has stalled; once determined, the Jury President must provide the competitor verbal instructions indicating how much time they have before their attempt is terminated. For example, a competitor on a route making no progress for several minutes may be instructed to make progress in the next minute or their attempt will be terminated.

Lead/Top Rope Formats in 12.8.1 are added for:

- Collegiate National Championship Final Round for Intermediate Category
- Paraclimbing National Championship Qualification Round

- a) Where the table provides for discretion, or a competition plus round appears more than once in the table, the format shall be at the discretion of the Jury President after consultation with the Event Organizer and the Head Routesetter.
- b) Format of the Lead/Top Rope competition: Isolation, Flash, or Modified Redpoint.
- c) All Categories at a given competition shall have the same number of routes.
- d) Subject to Sport Discretion (Rule 1.9.2), Youth Qualification Series and Collegiate Qualification Series Flash Format competitions may utilize a Climbing Period of 4 minutes.
- e) Modified Redpoint aspects contained within "[]" in the above table are subject to Rule 7.8.3.

- a) Where the table provides for discretion, or a competition plus round appears more than once in the table, the format shall be at the discretion of the Jury President after consultation with the Event Organizer and the Head Routesetter, except for the following:
 - i) The number of zones on a boulder, where such discretion is provided in the table, shall be at the discretion of the Head Routesetter in consultation with the Jury President.
- b) All Categories at a given competition shall have the same number of Boulders.
- c) Modified Redpoint aspects contained within "[]" in the above table are subject to Rule 8.10.3.
- d) Rotation Redpoint Format in the Final round of the Collegiate National Championships shall:
 - i) utilize a start list ordered by Qualification round rank (best ranked starting last); and
 - ii) not be allowed for Advanced Categories.
- e) Rotation Redpoint at the Youth Divisional Championship must use either:
 - i) one (1) course of four (4) boulders, five (5) boulders, or six (6) boulders; or
 - ii) two (2) courses each of two (2) boulders or three (3) boulders,

where competitions that use a single course of boulders should utilize a seeded Start Order based on Regional Championship ranking (highest ranked ordered last),

though the seeding method and the number of courses and boulders of Rotation Redpoint at the Youth Divisional Championship is subject to Sport Discretion. The Final round appeal deadline in 12.13.1 for "Elite" Series competitions is updated:

12.13.1 The following table sets forth appeal fee and select deadlines of USA Climbing Lead/Top Rope and Boulder competition rounds.

- a) The deadline regarding making an appeal relating to the scoring or ranking of any competitor (Rules 7.13.6(b) and 8.15.5(b)) shall be as indicated in the table above, where the relevant entry in the table is either:
 - i) "Immediate", meaning immediately following the display of the relevant competitor's Provisional Result (or where no Provisional Result is displayed, the Official Result); or
 - ii) the number of minutes after the publication of the Official Results.
- b) Unless remaining time to submit appeals is waived by all competitors after publication of the Official Results.
