# **Eligibility** | 2025 National Team Rankings

The athlete eligibility List for each discipline can be found on the 2025 National Team Rankings, where eligible competitors will have a "yes", noted under 'NTT Eligible'. Eligibility for the 2025 National Team Trials is defined in Section 4.2 of the Team Selection Procedures.

Athletes eligible for the Speed discipline may refer to Section 4.2.2 of the <u>Team Selection</u> Procedures and the 2025 Elite Series Speed Benchmark Times.

Registration will open Wednesday, January 8<sup>th</sup>, 2025 at 12:00pm (*Noon*) Mountain Time and will close Tuesday, March 11<sup>th</sup>, 2025 at 12:00pm (*Noon*) Mountain Time. The entry fee will increase two times: at midnight at the end of Thursday, February 27<sup>th</sup>, 2025, and at the end of Monday, March 3<sup>rd</sup>, 2025, both Mountain Time.

Competitors may only register for the discipline(s) of which they are eligible and if found to have registered for a discipline they are not eligible, will be refunded (less any processing fees) and removed from the ineligible discipline.

Each competitor is additionally responsible for ensuring they are registered for the correct discipline(s) prior to the closure of any registration deadline(s) by verifying against their confirmation email and/or against the Public Event Registrant List. # Coach Registration & Check-In | Register Here

All Coaches at the 2025 National Team Trials must have a Current Certified Coach membership.

Coaches will be required to register for the "2025 National Team Trials Coaches Registration" event prior to checking in.

- The free registration will open in conjunction with the competitor registration and can be found by logging in to your USA Climbing account under "Events".
- Coaches will be required to scan their electronic or PDF membership card upon check in at the event.
- Membership cards can be found in the membership confirmation email. The PDF card can be printed, or the electronic card can be downloaded to your smartphone.

Prior to the competition all competitors must complete a gym waiver for Mesa Rim - Austin.

# **Competitor Check-In**

All Competitors must check-in during their respective check-in times as outlined on the schedule. Competitors will receive their competition bibs at check-in for each discipline(s) and will be expected to wear them in the middle of their back throughout the competition. Bibs must also be kept through all rounds of competition. Prior to the competition all competitors must complete a gym waiver for <a href="Mesa Rim - Austin">Mesa Rim - Austin</a>.

## **Competitor Seeding & Start list:**

Competitors shall be seeded in order of the 2025 National Team Trials eligibility in Boulder, with higher ranked competitors seeded ahead of lower ranked competitors. The utilization of one (1) starting group will be utilized for each gender.

For the Lead and Speed disciplines, the starting orders will be randomized.
